The new application will be far more obtrusive and as this property is located in the centre of the village (a conservation area), overlooking the village green, the Parish Council believes more consideration should be given to the "street -scene"- a flat-roofed extension is not appropriate here. If this application is given permission perhaps the existing roof line could be continued over the new extension....?" (Unanimous)
