- Letter from applicant -22/00593/FUL, Gravel Pit Farm, Sand Hutton "We have received a copy of your objections to our planning application 22/00593/FUL and would like you to reconsider for the following reasons:
- Associated wear and tear to the public highway by existing traffic from this site, which has left the road in a poor state. This is the responsibility of the Highways. They have approved the application, subject to conditions which we are happy to accept and were part of our plans anyway. When the road shoulder re-instatement works were completed by Ryedale Highways last year, they did not include the stretch from FERA to the Gravel Pit Farm entrance. This has left the roadsides distressed and the work needs finishing.
- Previous use of the site has resulted in excessive loud noise well after midnight by agricultural vehicles travelling through Sand Hutton. This is an extremely rare occurrence i.e.

once in the last twelve months. It has nothing to do with this application. Due to the nature of farming, the farm very occasionally has to work late because of a weather window i.e. harvesting. We would never work late at night deliberately to cause a nuisance, and try to use the A64 whenever possible, thus avoiding the villages. There are at least eight other farms which run tractors through Sand Hutton, it is unfair to assume that they are all from Gravel Pit Farm.

- These vehicles would have travelled close to the proposed development. We have already mitigated any farm vehicles travelling close to the proposed development, with the addition of a bund around the proposed curtilage. The proposal of a bund was suggested by ourselves and has been agreed as a satisfactory solution with the planning officer and the environmental health officer.
- Current maintenance of roads on the site, the roads are not well maintained and are covered in uneven deep muddy puddles. As part of the development, this road surface will be completely renewed to a high standard. This road will run through to the farm and the AD Site, so will be easy to maintain and keep clean. We also propose to upgrade a farm track to by-pass Sand Hutton village for most operations in the near future.

We hope these answers will satisfy your concerns about this small development and that you can withdraw your objection.

We also hope that everyone can work together towards better relations between the farm and the village for the future. This is certainly the intention of our family and our staff".

<u>Resolved</u> – The Parish Council thanked the applicant for their email, but confirmed that the content did not persuade the Parish Council to withdraw their objection. (Unanimous)
